### **NEWS OF AND FROM MEMBERS**

Angelos Chaniotis published, as an appendix to an article about Aphrodisias in Caria, "Inscriptions from Bucak Köyü (Anceint Syneta?)," in *American Journal of Archaeology* 102 (April 1998), 248-50.

Henry R. Immerwahr has finished a preliminary version of his *Corpus of Attic Vase Inscriptions* (CAVI). This preliminary edition is in five volumes and contains 8,137 items. There is a Greek index. Except for merchants' marks, the aim has been to include all writing, painted or scratched, found on Attic pottery. Hard copies of the corpus exist at present at the University of North Carolina, the American School of Classical Studies in Athens, and the Beazley Archive, Ashmolean Museum, Oxford. An electronic copy has been sent to the Packard Humanities Institute for inclusion in the next version of the PHI disk containing the Greek inscriptions.



# POST-DOCTORAL FELLOWSHIPS AT OHIO STATE UNIVERSITY

The Center for Epigraphical and Palaeographical Studies at The Ohio State University offers short-term fellowships (of one to four months duration) to support visitors pursuing post-doctoral research in Greek and Latin history and epigraphy. The fellowships pay for travel to and from Columbus and a living expense of \$1,500 per month. Recipients are expected to be in residence during the tenure of the award and are encouraged to participate in the activities of the University.

The Center's holdings include, in addition to a comprehensive library to support the study of Greek and Latin inscriptions, Arthur and Joyce Gordon's photographs and squeezes of Latin inscriptions, J.K. Evans's photo archive of Latin inscriptions from north Italy, J.M.R. Cormack's papers, photographs, and squeezes of inscriptions from Macedonia, Sterling Dow's and A.G. Woodhead's collections of offprints, and other materials, including numerous squeezes of Greek inscriptions.

Applications are now being received for academic year 1999-2000. There is no application form, and instead applicants are requested to submit a CV and a brief research proposal (not to exceed three pages) to Professor Stephen V. Tracy, Center for Epigraphical and Palaeographical Studies, The Ohio State University, 190 Pressey Hall, 1070 Carmack Road, Columbus, OH 43210-1002. The applicant should also arrange to have two letters of recommendation sent to the Director. Deadline for receipt of application materials: January 31, 1999.

WEB PROBLEMS: epigraph-l and Cornell Greek Epigraphy Project Offline by Tom Elliott (November 24, 1998)

Two separate and unrelated web server crashes have recently affected the epigraphic world. David Meadows, who administers the epigraph-I discussion list, reports that his server is down due to a hardware failure. Until he can have the system repaired, the epigraph-l list will be on hiatus. Kevin Clinton reports that the web server hosting the Cornell Greek Epigraphy Project's web site, Nancy Kelly's Delphi Bibliography, John Mansfield's Infimae Aetatis page (checklists of sources for ICE/ICI on the PHI Documentary CD #7), and other resources has suffered a catastrophic disk failure. The Project is currently exploring options: to replace the disk, or replace the entire server. Until a solution is found and implemented, these resources will be unavailable.

Changes in these situations will be announced as soon as they are known at:


