# CALL FOR PAPERS

ASGLE/SCS PANEL, 2022 SCS Annual Meeting "Epigraphy and Gender in the Graeco-Roman World" Organized by Jonathan Edmondson (York University)

From honorific statue-bases in public spaces to epitaphs displayed in burial grounds to inscribed votives set up in public sanctuaries or private cult spaces, inscriptions played a key role in defining gender norms in ancient Greece and Roman. Less formal types of writing such as graffiti or cursetablets may have contested or reinforced these societal norms.

This panel seeks to explore gender relations across full a range of social levels: from the elite to the "middling sort" to slaves and manumitted slaves. It is often argued that it is difficult to uncover authentic female voices within epigraphic repertoires, since men controlled the production of most inscriptions. Is it possible, using new interpretive techniques, to read epigraphic texts against the grain and thereby uncover previously ignored aspects of gender relations? The panel ideally will present a variety of methodological approaches ranging from close readings of individual texts to broader analyses of texts in bulk drawn either from single locations or wider geographical contexts, from where appropriate, involving comparative discussion.

Abstracts should be a maximum of 500 words (bibliography excluded), suitable for a 20-minute presentation. Please follow the SCS "Guidelines for Authors of Abstracts" and ensure that no reference is made to the author's identity. Send your anonymous abstract, as Word or PDF e-mail attachment, Jonathan Edmondson to at jedmond@yorku.ca by March 15, 2021. Abstracts will be evaluated anonymously by two reviewers. (Authors submitting abstracts <u>must</u> be SCS members in good standing and will need to register for the 2022 SCS meeting.)

# THE CENTER FOR EPIGRAPHICAL AND PALAEOGRAPHICAL STUDIES AT THE OHIO STATE UNIVERSITY

The Center for Epigraphical & Palaeographical Studies at The Ohio State University in Columbus, Ohio is the only comprehensive research facility for the study of Greek and Latin inscriptions and manuscripts in the United States.


The Center maintains an excellent library of books on epigraphy and palaeography in addition to an extensive collection of photographs and squeezes of Greek and Latin inscriptions, as well as microfilms of Latin manuscripts. Many of these Greek materials were donated by the Center's founder and first director, OSU Professor Emeritus (and ASGLE Past President) Stephen V. Tracy.

Other special collections include: the Arthur E. Gordon and Joyce S. Gordon Collection of squeezes and photographs of Latin inscriptions; the Charles L. Babcock Collection of squeezes from the American Academy in Rome; the J.M.R. Cormack Macedonian Collection of squeezes; the Julian Plante Collection; the Grundy Steiner Microfilm Collection of Latin manuscripts; and the Virginia Brown Beneventan Collection. Ohio State is a long-time participant in the <u>PHI</u> <u>Project</u>. This searchable online database of Greek epigraphical texts was developed in cooperation with Cornell University and with funding and technical support from the Packard Humanities Institute. Work at the Center is directed by Philip Forsythe. The Center also serves as a meeting place for epigraphists and palaeographers: the annual <u>Virginia Brown Memorial Lecture</u> and associated <u>Texts and Contexts Seminar</u> brings researchers from around the world to Columbus. The most recent inperson 2019 meeting hosted both current ASGLE President Rebecca Benefiel and Secretary-Treasurer Stephanie Ann Frampton.

The Center offers short-term fellowships of one to four months duration for those pursuing post-doctoral research in Greek and Latin epigraphy and Latin palaeography. Fellows receive a stipend of \$1,600 per month, are expected to be in residence during the tenure of the award, and are encouraged to participate in the activities of the University. Applicants are requested to submit a curriculum vitae and a brief research proposal (not to exceed three pages) to the Director, as well as to arrange for two letters of reference.

[Please note that due to the pandemic, applications will not be accepted for 2021-2022 in order to give the scholars accepted for 2020-2021 additional time to take up their fellowships. The Center hopes to accept applications again for 2022-2023 in the autumn of 2021.]

#### NOW IN PAPERBACK

Michael Gagarin and Paula Perlman, *The Laws of Ancient Crete c. 650-400 BCE* (OUP 2016) is <u>now</u> <u>available in paperback for \$40</u>.

#### **BYZANTINE PAPYRUS AMULETS**

Michael Zellmann-Rohrer (Oxford) has published "Lawsuits with Headless Foes: A Greek Incantation Motif" in the 2020 volume of *Archiv für Religionsgeschichte* (vol. 21-22, no. 1: 51– 83). The study proposes a new interpretation of the texts of two late ancient or early Byzantine papyrus amulets that refer to "headless" entities (PGMP5a–b).

#### HASMONEAN INSCRIPTIONS FROM TEL GEZER

Noah Kaye (Michigan State) reports that his article, "Purity and Property at Gezer: The Commons in a Second Temple Town" has just appeared in the *Journal for the Study of Judaism* (2021), pp. 1-38. It publishes new interpretations of a series of rupestral, Greek-Aramaic boundary stones from Hellenistic Gezer, which place accent on the delineation of collective property rights under Hasmonean rule. The article also includes the *editio princeps* of a Greek grave stele once spotted in use as the threshold of a Hasmonean house.

#### VESTAL VIRGINS AND ROMAN EPIGRAPHY

Morgan Palmer (Nebraska) has published "Time and Eternity: The Vestal Virgins and the Crisis of the Third Century" in the fall 2020 issue of *TAPA* (vol. 150: 473–97). This article historicizes inscriptions from the atrium Vestae with the crisis of the third century, examining how the traditional theme of time and eternity gained additional significance amidst concerns for the future of Rome.

M. Fernández Corral announces the publication of <u>La epigrafía funeraria de época romana del área</u> <u>autrigona: conmemoración, relaciones familiares y</u> <u>sociedad.</u> Madrid: Anejos del Archivo Español de Arqueología, Editorial CSIC, 2020.


The book includes the epigraphic corpus of the funerary inscriptions of the Autrigonian territory and their analysis, including the chronology, typology, decoration, onomastics and, more importantly, the representation of the different social groups in the epigraphy, their family relations and an analysis of the ensemble from a social perspective


# PROCEEDINGS OF THE SECOND NORTH AMERICAN CONGRESS OF GREEK AND LATIN EPIGRAPHY PUBLISHED

#### Nikolaos Papazarkadas reports:

I am happy to announce the publication of Emily Mackil and Nikolaos Papazarkadas (edd.), *Greek Epigraphy and Religion: Papers in Memory of Sara B. Aleshire from the Second North American Congress of* 

Greek and Latin Epigraphy (Brill Studies in Greek and Roman Epigraphy no. 16) (Leiden and Boston 2021). In *Greek Epigraphy* and Religion editors E. Mackil and N. Papazarkadas bring together a series of papers first presented at a special session of NACGLE 2 (Berkeley 2016). That session was dedicated to the memory of Sara B. Aleshire, one of the leading Greek epigraphists of the twentieth century. Greek Epigraphy and Religion includes a combination of previously unpublished inscriptions, overlooked epigraphical documents, and well-known inscribed texts that are reexamined with fresh eyes and approaches. The relevant documents cover a wide geographical range, including Athens and Attica, the Peloponnese, Epirus, Thessaly, the Aegean islands, and Egypt. This collection ultimately explores the insights provided by epigraphical texts into the religious beliefs and practices of the ancient Greeks, but also revisits critically some entrenched doctrines in the field of Greek religion.





The new volume together with C. Noreña and N.Papazarkadas (edd.), *From Document to History: Epigraphic Insights into the Greco-Roman World* (Brill Studies in Greek and Roman Epigraphy no. 12) (Leiden and Boston 2019) brings to full completion the Second North American Congress of Greek and Latin Epigraphy that was organized in 2016 at Berkeley under the aegis of the American Society of Greek and Latin Epigraphy.

THE AMERICAN SOCIETY OF GREEK AND LATIN EPIGRAPHY (ASGLE), founded in 1996, is a nonprofit organization whose purpose is to further research in, and the teaching of, Greek and Latin epigraphy in North America. The Society fosters collaboration in the field and facilitates the exchange of scholarly research and discussion, both in the public forum and in published form. It sponsors a thematic panel each year at the meetings of the Society of Classical Studies (formerly the American Philological Association) and an international congress every five years.

Membership in ASGLE is open to all person interested in the study and promotion of Greek and Latin epigraphy and related disciplines. Full membership, for college and university faculty in North America, includes membership in *L'Association Internationale pour l' Épigraphie Grecque et Latine* (AIEGL). A reduced-rate membership does not include membership in AIEGL and is available for students, independent scholars, retired faculty, and foreign scholars who are already members of AIEGL.
