It will be a pleasure to see you all at the SCS-AIA meeting in Chicago in early January and especially at the 4th North American Congress of Greek and Latin Epigraphy, to be held at the Institute for the Study of Ancient Cultures (ISAC, formerly the Oriental Institute) at the University of Chicago on January 8-9, 2024.

For NACGLE IV we have an exciting programme with an excellent range of papers in both Greek and Latin epigraphy, and there are also some sessions devoted to new methods for epigraphic research. Epigraphy and Public Life in the Graeco-Roman World

The Organizing Committee of the upcoming Fourth North American Congress of Greek and Latin Epigraphy (NACGLE) is pleased to invite individual proposals for poster presentations. Posters may be devoted to the importance of epigraphy for our understanding of any of the following topics: civic, political and legal activity; economic production and exchange; social hierarchies and social mobility; rural communities and agrarian life; military communities. Posters devoted to discussions of new inscriptions and new techniques for reading epigraphic texts and analyzing inscriptions in bulk will also be welcome.

Proposals should be between 350 and 500 words (bibliography excluded) and be anonymous. Please submit your proposal by email attachment in PDF or Word document format by Monday 27 November 2023 to NACGLE2024@gmail.com. Please include the words "NACGLE IV POSTER" in the subject line of the email.

Proposals will be reviewed anonymously by members of the congress Organizing Committee, and the results of the review process will be made known to potential participants soon thereafter. Please note that those whose posters are accepted will have to make their own arrangements for printing and bringing their posters to Chicago (there is a FedEx Office Print shop at 1315 E 57th St., within easy walking distance of the conference location at the ISAC and the conference hotel, The Sophy, 1411 East 53rd St.).

To submit a proposal for a poster, it is not necessary to be a current member of ASGLE, but we hope that all those whose posters are accepted for presentation in Chicago will join ASGLE, if they are not already members.

2025 SCS Annual Meeting Calls for Papers

The American Society of Greek and Latin Epigraphy will be teaming up with the American Society of Papyrologists to offer two joint panels at the 156th Annual Meeting of the Society for Classical Studies, January 2-5, 2025, in Philadelphia. The aim of this collaboration is to promote collaboration and interaction between papyrologists and epigraphists on topics of mutual interest to both.

Joint Panel 1:

Organization, Display, and Transfer of Knowledge

A Joint Panel Sponsored by the American Society of Greek and Latin Epigraphy and the American Society of Papyrologists

> Organized by James Sickinger (Florida State University) and Christelle Fischer-Bovet (University of Southern California)

This panel aims to explore how epigraphical and papyrological documents organize, display, and disseminate knowledge and information in the ancient societies of the Mediterranean and the Near East. While, on a most basic level, epigraphical sources serve to display information and papyrological ones allow for its transfer and dissemination, both partake in its organization and can also serve multiple functions. Our two scholarly associations seek to bring together papers addressing specific aspects of these broad problematics from either papyrological or epigraphical perspectives, or both, to offer a more nuanced understanding of variations, influences, and local adaptations.

We invite abstracts that engage with – but are not limited to – administrative or legal practices, whether institutional or private; economic and accounting procedures and issues of transparency; memory, local history and archives; the transfer or display of cultural and religious knowledge and values; the relationship between archives, material culture, and the intersection between different material supports, i.e., what types of knowledge or information are displayed or archived, how and where, and with what sorts of outcomes or limitations? In sum, we envision inquiries that explore how the perspectives of epigraphy and papyrology interact: do they complement or contradict one another?

Papers should deploy evidence preserved either epigraphically (on stone, metal, or other durable material) or on papyri, ostraka, or wooden tablets, and written in Greek, Latin, Coptic, demotic Egyptian, Arabic, or other pertinent languages. Papers engaging with a combination of materials (e.g., inscriptions and papyri) or take a comparative approach, as well as multi-authored papers pairing epigraphers and papyrologists, are also welcome.

New Directions in Papyrology and Epigraphy in the 21st Century

Joint Panel Sponsored by the American Society of Greek and Latin Epigraphy and the American Society of Papyrologists Organized by James Sickinger (Florida State University) and Christelle Fischer-Bovet (University of Southern California)

The American Society of Greek and Latin Epigraphy and the American Society of Papyrologists both represent disciplines that are unique for providing new primary sources for study of the ancient world. Both societies also wish to promote dialogues between these two fields, and we therefore jointly invite proposals for papers reflecting the ongoing contributions of papyrological epigraphic material by addressing recently discovered epigraphic or papyrological texts, reinterpretations of older documents, or new methodological approaches to the study of epigraphic or papyrological texts (or both). Papers may address individual texts or groups of texts, as well as similarities or differences arising from the study of documents on different materials.

Papers should deploy evidence preserved either epigraphically (on stone, metal, or other durable material) or on papyri, ostraka, or wooden tablets (in Greek, Latin, Coptic, demotic Egyptian, Arabic, or other pertinent languages). Papers that engage with a combination of materials (e.g., inscriptions and papyri) or take a comparative approach, as well as multi-authored papers pairing epigraphers and papyrologists, are also welcome.

The congress will take place at the Institute for the Study of Ancient Cultures (ISAC, formerly the Oriental Institute) on the campus of the University of Chicago and will be held immediately following the Annual Meeting of the Archaeological Institute of America and the Society for Classical Studies in Chicago (January 4-7, 2024).
